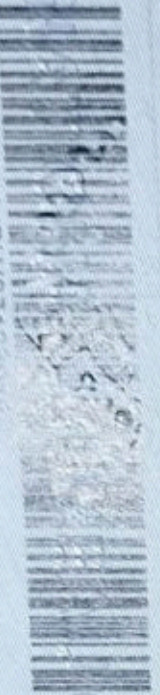



The osseous thoracic cage showed no significant bony abnormality.

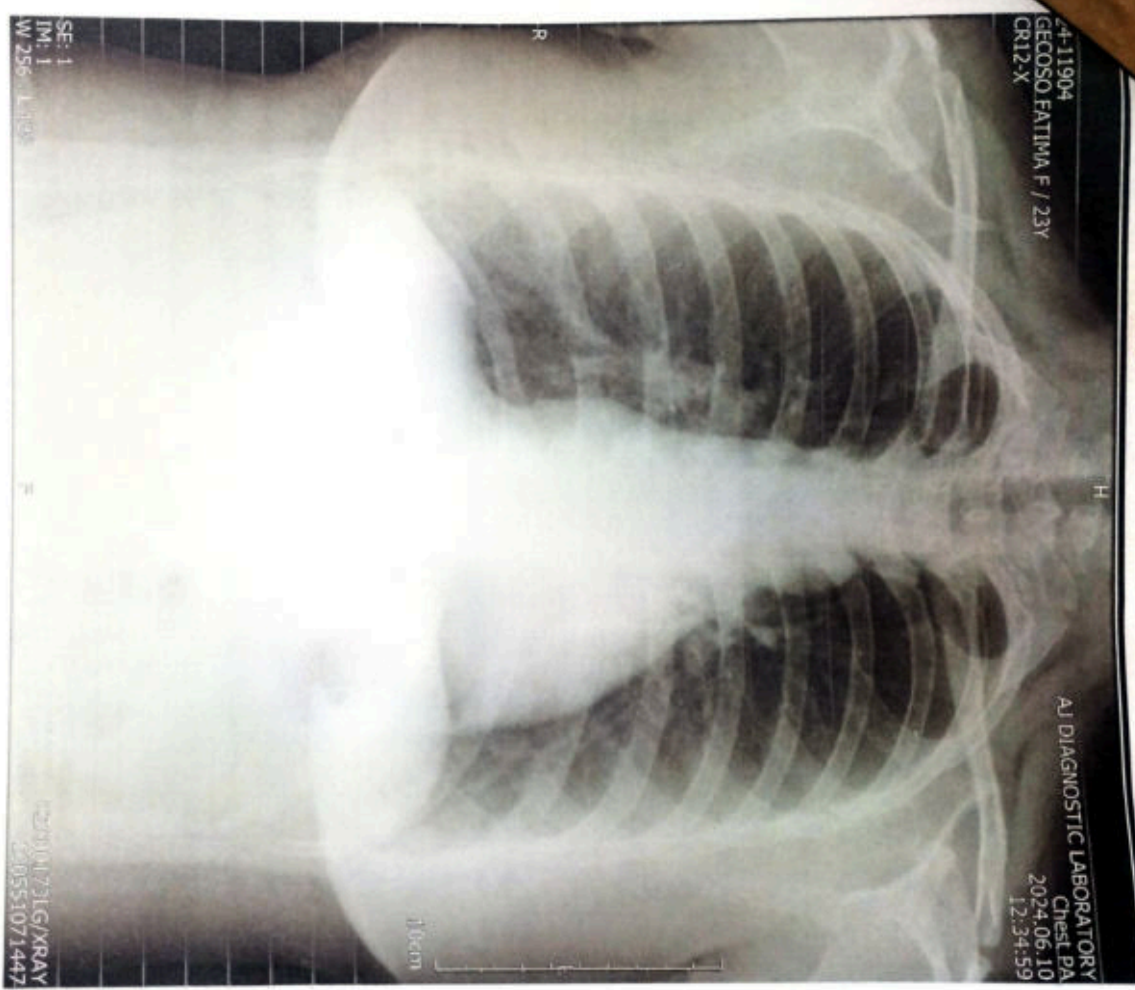
