

OATH OF UNDERTAKING



1. That this is the first time that I will actively look for a job, and therefore requesting that the Barangay Certification be issued on my favor to avail the benefits of the law;
2. That I am aware that the benefits and privilege/s under the said law shall be valid for one year from the date the Barangay Certification was issued;
3. That I can avail the benefit of the law only once;
4. I understand that my personal information shall be included in Roster/List of the First Time Jobseekers and will not be used for any unlawful purpose;
5. That I will inform and/or report to the barangay personally, through text or other means, or through my family/relatives once I get employed and
6. That I am not a beneficiary of the Job Start Program under RA No. 10869 and other laws that gives similar exemption for the documents of transaction exempted under RA No. 11261;
7. That If issued the requested certification, I will not use the same in any fraud, neither falsify nor help and/or assist in the fabrication on the said certification;
8. That this undertaking is made solely for the purpose of obtaining a Barangay Certification consistent with the objectives of RA No.11261 and not for any other purpose.
9. I consent to the use of my personal information pursuant to the Data Privacy Act and other applicable laws, rules and regulations.
