What is **Medicare**?

Medicare is a government funded program. One of the qualifications is you have to be 65 years or older. Medicare provide medical health benefits to its members.

What is **Medicaid**?

Medicaid is only limited per state, its benefits will depend on how big or small the state is. People who are part of the low income subsidy and has limited resources can be eligible for Medicaid.

What is **Deductible**?

Deductible is the total amount the member needs to pay out of pocket before the insurance company will help pay their bills. For example, patient has a \$250 deductible per year, then that is the amount he needs to satisfy first before insurance company will help pay for his medical bills.

What is the Difference between **Co-insurance** and **Copay**?

Coinsurance is the percentage amount patient pays and Copay is a fix amount or flat fee the patient has to pay. For example for Co-insurance insurance will pay 80% of the medical bills and patient only pays for the remaining 20% of the medical bills.
