What is *Medicare*?

The difference between co-insurance and copay is for co-insurance you will only be paying the remaining amount of what the insurance company is paying for example out of \$100 covered insurance the company will only pay 80% of the covered insurance which is \$80 so the remaining \$20 is what you pay.
