What is **Medicare**?

It is a national ~~health~~ healthcare organization funded by the government to assist patient needs. There are three qualifications to be eligible for Medicare. These are: (1) patient should be 65 years old or above, (2) should be a person with disability (PWD), or (3) patient should have ESRD (End Stage Renal Disease).

What is **Medicaid**?

It is a health assistance funded by each state. Persons who have low sources of income or limited resources are eligible to avail of such assistance.

What is **Deductible**?

The deductible is an amount needed to be paid or satisfied by the patient to start their insurance. After this amount is paid through doctor visits, buying medicine, etc. the insurance will take effect.

What is the Difference between **Co-insurance** and **Copay**?

Co-insurance is the percentage the patient needs to pay, while co-pay is the fixed fee to be paid by the patient.
