Co-insurance is the percentage you get in your insurance, once the insurance company is satisfied they will provide what percentage they will cover, mostly 20% for you and the other 80%, the insurance will cover it for you. While the copay, it is a fixed rate that you pay for your bill. For example, you get hospitalized then they will prescribe you a prescription, then that prescription will be shouldered by you.
