What is the Difference between **Co-insurance** and **Copay**?

Co-insurance is the percentage that you will pay on behalf of the insurance company while copay is the fixed rate or flat fee that you will pay. In other words, copay do not change or is a fixed amount while co-insurance will differ depending on the percentage.
