What is **Medicare**?

Medicare is a health insurance that is fully funded by the national government. The only qualified individuals who can avail this are ages 65+ and has specific or critical health situation or case - and they must be American citizen.

What is **Medicaid**?

Medicaid is also like Medicare but has two different contributors, the national government and the state government. The individuals must be an American citizen that has low income salary.

What is **Deductible**?

Deductible is the payment you do to validate health insurance. It is (~~what~~) what you must reach in order to be able to ~~use~~ allow your health insurance cover your next hospitalization within the month of validation.

What is the Difference between **Co-insurance** and **Copay**?

Co-insurance is when your health insurance helps you cover your hospital/medical bill, where your bill will be shouldered by them - or at least be shouldered (~~at~~) 80% and let you pay for the 20%.

Co-pay is the out-of-pocket money expenses (~~for other~~) during or after hospitalizations. It is not shouldered by the (~~company~~) health insurance, expenses like medicines.
