What is the Difference between **Co-insurance** and **Copay**?

CO-INSURANCE IS THE PERCENTAGE AMOUNT THE PATIENT NEEDS TO PAY ON BEHALF OF THEIR INSURANCE COMPANY, WHILE COPAY IS THE FLAT RATE AMOUNT. AN EXAMPLE OF CO-INSURANCE IS 20% FOR THE PATIENT AND 80% FOR THE INSURANCE COMPANY.
