However, Co-insurance can also differ for example the insurance company will fund the expenses 80% then the client will do the 20% or could be 90-10% ratio. On the other hand Copay means there's an exact or fix amount given to specific or to clients. Best example is \$50 for each medical expenses so if your total is \$100, you need to pay the remaining balance.
