What is the Difference between *Co-insurance* and *Copay*?

Co-insurance is the amount that the patient pays to the insurance after the deductible; a part of the amount paid by the patient is ^{already} covered by the insurance company, usually amounting to 80%. For co-pay, there are fixed rates or amounts that patient needs to pay, such as doctor visits and prescriptions.
