What is **Medicare**?

• Medicare is an medical insurance from U.S.A. ~~It covers the percentage of the customer's expenses~~. The effects on beneficiaries does not differentiate from states. The specific customers that can receive the benefit of this insurance is 65 years old and above, PWDs, Etc.

What is **Medicaid**?

• Medicaid is also a medical insurance <sup>from the United States</sup> ~~that covers flat-expense, for example Medicaid covers only 50 dollars from your expense from your insurance~~. • The people that can benefit from this insurance are people who has limited resources and struggles financially. The cover of the expense depends on what state you are in.

What is **Deductible**?

• Deductible is when you have to pay partially so that when the payment has been completed, they will benefit the insurance. for example - the customer wants to pay 150 dollars and he/she does it or pays it partially for 50 dollars per week so after 3 weeks he/she will have the benefit of the insurance.

What is the Difference between **Co-insurance** and **Copay**?

• The difference between Co-insurance and Copay is that Co-insurance only covers a percentage of a customer's expense while Copay on the other hand only covers flat-expense. for example Co-insurance covers 25% of the 100 dollar expense so the customer would only have to pay 75 dollars. An example of a co-pay is when the insurance only covers 50 dollars for the 100 dollars expense, so the customer would only have to pay 50 dollars.
