What is *Medicare*?

What is *Medicaid*?

Medicaid provides financial aid to people who are qualified for it. This includes people who have low income or low of resources.

What is *Deductible*?

Deductible is the amount of money that the insured person must pay before their insurance policy starts to cover their medical expenses. For an example, an insured person ~~##~~ needs to pay \$250 before their insured policy starts to pay the ^{rest of} ~~the~~ their medical expenses.

What is the Difference between *Co-insurance* and *Copay*?

Coinsurance means the insured person and their insurance policy will be covering specific percentage of the ^{medical} expenses. For an example, the insurance policy will cover 80 percent while the insured person covers the rest of the percentage ^{which} ~~is~~ basically the 20%, while copay is a ^{most} flat rate or fixed rate that the insured person will cover ^{likely} for a medical prescriptions.
